This rendition of Part V has been conformed to the official version on the US Code website. Also, it (a) has a **one-page cover sheet** providing an **orientation to the reorganization**, and (b) includes **bracketed citation notes** showing the source section for each new section and footnotes with explanatory comments on some of the revisions and recent amendments.

This document is in order by former title 10 section numbers and shows how each transferred section is renumbered and where it goes in the new Part V. This is similar to the information on the front of the website, but has additional content, showing the chapter structure of the old law and the chapters to which section are transferred, as well as citing the NDAA sections which made the actual transfers and providing some explanatory notes.

[Crosswalk document “New to Old Section Tracker”](#)

This is the reverse of the first tracker, organized **in order by new section numbers**. It shows the organization of the new Part V. Like the other tracker, it has citations for the NDAA sections making the transfers and some explanatory notes. It also shows where there are parallel provisions applicable to non-defense procurement (in title 41, USC).

Note:

1. **The Full Statute Text** document *is the full text of Part V in one convenient, searchable document* as now in effect. It includes a number of notes that should be useful to users that do not appear in the official US Code website AND, for ease of reference, shows the original section number for each section in brackets immediately after the new section number.
2. **The Chapter Organization** document is a brief document showing the chapter structure of the new Part V and the effect of the reorganization on the previous chapter in Part IV of subtitle A of title 10.
3. **The Crosswalk documents** are similar to the Old/New table, one also structured by Old to New, the other by New to Old section numbers. *However, they show substantial additional information*, including the sections within the context of the title 10 chapter structure (both old and new), NDAA section numbers that made each transfer, and explanatory notes.

Overview of the effect of the reorganization on previous title 10 chapters:

As of Dec. 31, 2021, the day before the effective date of the reorganization of the acquisition-related sections of title 10, the chapters of title 10 relating to defense acquisition appeared within a larger “Part” labeled “Service, Supply and Procurement”. Those chapters, each of which (other than ch. 141) was either transferred or repealed by the reorganization, are the following:

Ch. 137, Procurement Generally. This was an original title 10 chapter which when enacted in 1956 was the codification of the Armed Services Procurement Act of 1947. As of Dec. 31, 2021, it had **56** sections on a wide variety of subjects, with sections designated from 2302 to 2339c and many designated by a combination of numbers and a letter.

Ch. 139, Research and Development. This is an original title 10 chapter. As of Dec. 31, 2021, it had **33** sections on a wide variety of subjects generally related to R&D, with sections designated from 2351 to 2374b and many designated by a combination of numbers and a letter.

Ch. 140, Procurement of Commercial Products and Commercial Services. This chapter was added in 1994 and as of Dec. 31, 2021, had 8 sections, designated from 2375 to 2380c.

Ch. 141, Miscellaneous Procurement Provisions. This is an original title 10 chapter which when enacted was the codification of permanent procurement provisions that were not part of the Armed Services Procurement Act of 1947 (which was codified as ch. 137). As of Dec. 31, 2021, it had **38** sections on a wide variety of subjects (some of which did not seem related to Procurement), with sections designated from 2381 to 2310s, with many sections designated by a combination of numbers and a letter (e.g., 2410s). The reorganization left six sections in this chapter and renamed the chapter as “Miscellaneous Provisions Relating to Property”.

Ch. 142, Procurement Technical Assistance Cooperative Agreement Program. This chapter was added in 1984 and as of Dec. 31, 2021, had 10 sections designated from 2411 to 2420.

Ch. 144, Major Defense Acquisition Programs (MDAPs). This chapter was added in 1986 as a consolidation of provisions of title 10 relating to MDAPs and as of Dec. 31, 2021, had 17 sections (some of which are among the most complex anywhere in title 10), with sections designated from 2430 to 2443.

Ch. 144B, Weapon Systems Development and Related Matters. This chapter was added in 2016 and as of Dec. 31, 2021, had 10 sections, with sections designated from 2446a to 2448b, each of which was designated by a combination of numbers and a letter (e.g., 2448b).

Ch. 148, National Defense Technology and Industrial Base, Defense Reinvestment, and Defense Conversion. This chapter was added in 1992 and as of Dec. 31, 2021, had **43** sections grouped into 7 subchapters and designated from 2501 to 2541d.

Ch. 149, Defense Acquisition System. This chapter was added in 2011 and as of Dec. 31, 2021, had 5 sections, designated from 2545 to 2548.
